The broad objectives of the Trust shall be as follows:

- i) To open, runs, continue educational and vocational Schools, Colleges, or Institutions in healthy and salubrious surrounding to provide primary to higher studies in Arts, science, Industrial, Technical, Nursing, Medical Science Colleges, Agriculture Institutions, Vocational and Professional courses.
- ii) To run "Teachers" Training Institute.

In case, however, a particular clause or clauses of the Instrument of Trust has been inadvertently clothed in a language capable of an interpretation in conflict with the relevant Income-tax provisions granting exemptions, it is hereby agreed, that such clause or clauses will have restricted meanings so that the relevant Income-tax provisions will always have the overriding effect.

### IV) OBJECTS INCIDENTAL TO THESE MAIN OBJECTS ARE:

- 1) To lease, purchase, build or otherwise acquire property / properties, both movable and immovable for carrying out the objects of the trust and to keep, repair alter and maintain same.
- 2) To seek, receive and accept property, cash or kind for any of the objectives and to use such donations and funds, for the purpose of the trust.
- 3) To accept gifts and donations, both in cash and kind, from individuals and organizations, Government or Non-Government both from within India and outside India, and also loans or credit facilities from banks and recognized financial institutions.
- 4) To invest funds in accordance with the provisions of Income-tax Act as may be decided by the Board from time to time.
- 5) To open and operate accounts with any bank/s, Bank a/c/s shall be operated by treasures cum secretary (or) by any other office bearer of the trust as may be decided by the Board, Power to operate the bank a/c/s/ shall includes the power to operate all OD,OCC or any other loan a/c of the trust.

"Trustees" means 'Board or Board of Trustees' which has the life trustees for the time being as its members and their successors appointed as trustees by the life trustees. With the consent of all the life trustees any one or more person/s shall be appointed either as life trustees or for any period as may be decided by the board of trustees from time to time.

### VI CONSTITUTION

Audited annual statement of accounts of all the institutions managed by the trust shall be presented by the secretary for consideration and adoption.

Annual report of activities of the trust shall be presented by the Secretary.

There shall be 15 day notice for the meeting and the quorum shall be three.

### XVI) ACCOUNTS & AUDIT:

The financial year of the Trust shall be April to March. The account shall be closed on 31<sup>st</sup> March every year. The accounts shall be audited by a Chartered Accountant or by a firm of Chartered Accountants in accordance with the provisions of the Income-tax Act and other Acts applicable to Trust: The Board shall appoint one or more auditors to audit the accounts of the trust and its institutions and fix their remuneration.

All funds of the trust shall be invested in banks or securities in accordance with the provisions of the Income-tax.

The trustees shall from and out of the income realized from the properties of Trust, and from such other endowments / grants which may be received from Government and donor agencies from time to time expend such sum /s of money as they may deem fit to carry out the objects of the trust.

The funds of the trust would be utilized solely towards the objects of the trust and no portion of it would be distributed in any manner to the trustees or persons defined Sec.13(1) (c) of the Income tax Act, 1961.

### VIII) POWERS AND DUTIES OF THE TRUSTEES:

The Founder President is having all the rights to appoint other trustees and also remove the trustees if the founder is not satisfied with the performance of the trustees so appointed by him.

The secretary of the Trust is empowered by this deed of trust to operate bank account in the name of the trust and to issue, receive all the payments whatever mode may be.

If any case, any borrowing, from Bank or Financial Institutions and from any individual person it should be done by both president and secretary.

The trustees shall be in complete Management of the affairs of the Trust and all institutions under the Management of the Trust.

-to sell, purchase, exchange and deal with any stocks, fund, shares, bonds, debentures, debenture stocks and other securities.

-to draw, make, endorse, negotiate, execute and issue promissory notes, bills of exchange, hundies, cheques, Government securities and other negotiable instruments.

-to borrow from time to time such sum or sums of money at such interest for such period and on such terms with or without security as the Board of Trustees may think fit and secure payment thereof with interest by mortgage or by issue of bond, promissory note, bills hundies or other negotiable instruments.

-to delegate all or any powers, authorities and direction vested in the Trustees and generally to carry out such transactions as they may consider expedient in the interest of the Trust and make all such arrangements and to do such acts and things on behalf of the trust as may be usually necessary, desirable or expedient in the management of the affairs of the Trust or in carrying out its objectives.

### XVII) REMUNERATION:

The Founder President, Secretary and the committee members may be paid suitable honorarium or remuneration for the services rendered by them as may be determined necessary by the Board of Trustees from time to time.

XVIII) All the activities of the Trust shall be carried out only within the territorial limits of India and no activity of the trust will be carried outside India except soliciting donations / grants / contributions from outside India.

XIX) The trust shall not carry on any activity with the intention of earning profit.

XX) Not more than 5% of the Income of the Trust / institution would be applied for any religious purpose or given to religious institutions.

### XXI) AMENDMENT:

The trust deed may be amended by a resolution passed by the entire Board of Trustees at a meeting of Trustees specially convened for the purpose after giving minimum 15 days notice. If any trustee is unable to attend such a meeting he shall give his opinion in writing either for or against the amendment specifically.

### XXII) DISPUTES AND ARBITRATION:

All disputes arising between the trustees themselves and the disputes between the Trust and its employees on any matter or subject relating to the affairs of the trust or its institutions shall be decided by a board of three arbitrators appointed by the Board of Trustees from time to time and the award of the arbitrators on such matters shall be final and binding on all the parties concerned.

APPEAL: Except on grounds referred to in Sec.30 of the Arbitration Act, 1940 no appeal would lei against the Board of Arbitrators.

### XXIII) DISSOLUTION:

This deed of declaration of Trust and the Trust herein declared is irrevocable, However both the life trustees can decide to dissolve the trust and in such on event the properties shall be transferred to societies / trusts with similar objects and registered under appropriate legislations.






